



# INFORMATION ABOUT THE 16<sup>TH</sup> INTERNATIONAL ON LINE TRADE FAIR OF PRACTICE ENTERPRISES, 16 February 2022

The fair will take place from 9 am to 5 pm, on Wednesday 16th of February 2022.

Admission is free for all visitors (PEs which are not exhibitors are also invited). From 9 am onwards, you will be able to "walk" between the stands and make business or chat with employees (each stand will have an online chat room).

### **EXHIBITORS**

Each stand will have an online chat room, **zoom link.** There must be two employees at the stand (in the chat room) throughout the fair, who receive potential "customers".

#### VISITORS

There is no admission fee for visitors (PEs). They will be able to "walk" between the stands from 9 am onwards and click on an online chat room of the stand, conclude a deal, or simply chat with employees. ALL INFORMATION FOR REGISTRATION FOR VISITORS ARE HERE.

### **PRESENTATION INTERVIEWS**

All PEs (**exhibitors**) **participate in presentation interviews** in front of the members of jury. The schedule and zoom link will be posted on our website on time. A maximum of two representatives of the PE without mentors participate in the presentation interview. They have **five minutes** to present their activities (without

If you are not at the interview at a certain time, you lose the right for presentation (you do not receive points). **The schedule and zoom link will be posted on our website on time.**
